#### Call to Order

Chair Steve Lindner called the Eastern Iowa Regional Housing Corporation Housing Trust Fund (EIRHC HTF) Board meeting to order at 9:01 a.m.

The meeting is being held by phone or internet means originating from the ECIA offices in Dubuque. It is open to the public and those in attendance can hear the proceedings. ## Review and Approve the Agenda for the EIRHC Housing Trust Fund (HTF) August 15, 2024 Board Meeting

Motion by Boss, second by Rheingans to approve the agenda for the EIRHC HTF August 15, 2024, Board Meeting. The motion passed unanimously.

# Review and Approve the Minutes of the EIRHC Housing Trust Fund (HTF) May 16, 2024 Board Meeting

Motion by Vick, second by Olberding to approve the minutes from the EIRHC HTF May 16, 2024, Board Meeting. The motion passed unanimously.

# Review and Approve EIRHC Housing Trust Fund (HTF) program expenditures for May – July 2024

Reimer presented the EIRHC HTF expenditures for May through July 2024 for approval, explaining the expenditures are normal and routine. Reimer noted payments to ECIA for the LEAD program, and payments to local newspapers to advertise for applications for 2025 projects.

Motion by Ludwig, second by Olberding to approve the program expenditures for May - July 2024. The motion passed unanimously.

### **Report on 2023 EIRHC HTF Project Activity**

Reimer said the 2023 projects must be completed with funds fully expended by December 31, 2024. All projects are on target to be expended. Reimer expressed he is confident the projects will be completed by the December 31<sup>st</sup> date.

#### **Report on 2024 EIRHC HTF Project Activity**

Reimer said the 2024 projects must be completed with funds fully expended by December 31, 2025. The owner-occupied unit is just starting to get some work done. The others are on target to be expended.

#### Review and Approve projects for 2025 Application

Application for 2025 projects closes on October 15<sup>th</sup>. Reimer stated staff are still looking for projects to be able to fulling expend funds. Reimer requested the board members to get the word out. Reimer referred to the handout stating the current projects are for some owner-occupied rehab, a few rental rehabs and one down payment assistance.

Motion by Rheingans, second by Gassman to approve projects for 2025 Application. The motion passed unanimously.

#### **Review and Approve Annual Report**

Reimer presented the board with the annual report. Reimer noted a consistent increase in funding from 2020 to present and expressed desire to get some larger projects going in Delaware and Cedar counties. Reimer noted this report will be submitted with the application for 2025 funding. Chair Lindner expressed appreciation for access to these funds.

Motion by Vick, second by Boss to approve the Annual Report. The motion passed unanimously.

#### Review and Approve 2025 Housing Assistance Plan

Reimer referred to the Housing Assistance Plan included in the agenda packet which the EIRHC HTF Board must approve every year. Reimer stated this plan has been updated to include the new Census data. No other changes have been made. Reimer explained staff will submit this plan to the Iowa Finance Authority (IFA) in October.

Motion by Olberding, second by Ludwig to approve the 2025 Housing Assistance Plan. The motion passed unanimously.

#### **Other Business**

Reimer noted the Board vacancies and requested the board members to spread the word to private sectors to gage interest to be a member of the HTF board.
